GENERAL BOOKING CONDITIONS

BOOKING AGREEMENT

1- Reservation Customer: To reserve a bare site or a rental accommodation, the customer must take a form of reservation after request either by telephone or by electronic mail or simply filled by Internet on www.camping-2b.com rubric "reservation".

An option perhaps put down from 1 to 7 days according to season. It becomes final once the down payment poured by Internet or by post, after approval of direction.

The montant of the down payment is in 30 % school stay + 15 \in of frais of management for a rental accommodation or $60 \in +$ 15 \in of expenses of file for a bare site. Accepted methods of payment: Kinds / Transfer / bank card / cheque / mandate cash.

- .2- Rental of a Mobil Home or a Ecolodge tent :
- a) an inventory and a survey of premises is done before you leave. A deposit of **250** € will be asked on your arrival and paid back on the day of leaving after checking your accommodation. An amount may be deducted for possible repairs costs. The renter is required to check the inventory on his arrival and to report any discrepancies.
- b) No refund will be given for any delayed arrival or early departure
- c) Your accommodation will be available on the **Saturday from 3p.m.** to **Saturday before 10 a.m.**
- d) The balance of the stay must be paid on the day of your arrival
- e) The accommodation is rented for a fixed number of 4 people for Ecolodge and of 4 for Mobil Home. All extra person will be charged as an additional adult.
- f) The cleaning of the rented accommodation is the renter's responsibility. The inside and immediate surroundings should be left in perfect clean conditions. A 50 €deposit in cash or CB will be asked on your arrival and refunded on the day of your departure.
- g) Smoking is totally prohibited inside Ecolodge tent and Mobil Home.
- **3- Delayed arrival**, if you have made a booking please inform us of a possible delayed arrival. Otherwise your accommodation or your pitch will be considered available for reletting 24h after your agreed arrival date.
- 4- Cancellation
- cancellation must be done by registered letter
- over 45 days prior to agreed arrival, your deposit will be refunded
- between 30 and 45 days prior to agreed arrival, your deposit will be kept
- less than 30 days prior to agreed arrival, the full cost of your booking will be kept
- The booking fees are never refunded
- 5- The renter must also underwrite a special insurance policy for civil liability
- **6-** Dogs must be vaccinated (certificate needed),kept on leash and under any circumstances should they be left alone.
- **7-** Visitors are requested to leave their car in the car park and to check in at reception. See 'pitch prices'
- **8-** Services will be reduced and may be stopped during the off-season (grocer's shop, snack, take away, activities, etc.)
- **9-** The occupants has to conform to the campsite rules and regulations
- 10- Swimming suits and trunks are required at the swimming pool and at the showers
- 11- The campsite barriers are open from 9a.m. to 11p.m. Beyond that time car traffic is prohibited within the campsite.
- **12-Beyond 11p.m.** any noise that may disturb others is forbidden and children of any age should be staying inside with their parents.
- 13- The rental implies the knowledge of general descriptions and inventory
- 14- Holiday tax and additional tax : 0,66 € per person per day for over 18 years
- **15-** For security reasons, our electrical network is not **suitable** for **charging** of battery and/or hybrid vehicles
